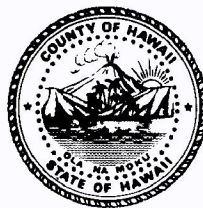

**Pursuant to Governor Ige's proclamation, in order to minimize physical contact and maximize social distancing, these meetings will not be open to the public.**

Governor David Ige's Emergency Proclamation Related to the COVID-19 Response, dated August 5, 2021, extended the suspension of Hawai'i Revised Statutes Chapter 92, Public Agency Meetings and Records, to the extent necessary to enable boards as defined in Section 92-2, to conduct meetings without any board members or members of the public physically present in the same location. This meeting will be held through a combination of some board members being physically present at the meeting location and some members participating by interactive video conference. Each person will be required to wear a face mask and maintain six feet physical distance from any other person as required by law.
