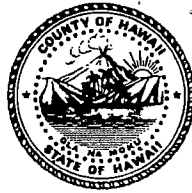

A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE FUNDS TO THE OFFICE OF THE MAYOR FOR THE HAWAI'I ISLAND CHEF CHALLENGE SHOW.

WHEREAS, the Office of the Mayor is putting on the first ever Hawai'i Island Chef Challenge show in the coming months, which will include partnering local chefs with keiki between the ages of 12 and 17; and

WHEREAS, starting in May, video segments for the show will be filmed at various locations around the island with the final segment shown in August featuring the finalists and Chef Sam Choy as celebrity judge; and

WHEREAS, the Hawai'i Island Chef Challenge will also share stories from our local farmers, ranchers, and chefs to learn about the challenges and rewards of our agriculture, culture, and culinary arts; and

WHEREAS, the Office of the Mayor is requesting funds to assist with expenses associated with coordinating and filming of the Hawai'i Island Chef Challenge show; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI'I that Contingency Relief funds from Council District 3 will be appropriated to the Office of the Mayor to provide funds for the Hawai'i Island Chef Challenge show.

BE IT FURTHER RESOLVED that the Council of the County of Hawai'i hereby transfers/appropriates the following amount as set forth below:
