

RESOLUTION NO. 99 21

**A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE A GRANT TO HAWAI'I PUBLIC HEALTH INSTITUTE TO ASSIST WITH EXPENSES RELATING TO ITS COMMUNITY OUTREACH EFFORTS.**

**WHEREAS**, Hawai'i Public Health Institute is a 501(c)(3) nonprofit organization that serves as a hub for health, bringing community-based organizations, government, academia, foundations and business together to improve the quality of life for the people of Hawai'i; and

**WHEREAS**, Tobacco Free Hawai'i Island, is a program under Hawai'i Public Health Institute, that created two informational info graphics "What's in a Vape" and "EVALI vs COVID-19" (know the warning signs) to be shared within hospitals, medical offices, community health centers, and Hawai'i Island public and private schools; and

**WHEREAS**, Hawai'i Public Health Institute is requesting funds to cover expenses for printing and laminating posters to educate and raise awareness about the impacts of vaping and other electronic nicotine delivery systems; and

**WHEREAS**, the Department of Liquor Control supports organizations that bring awareness and education to our youth and community to live a healthy, alcohol-free, and drug-free lifestyle; and

**WHEREAS**, pursuant to Section 2-139(a)(2)(A) of the Hawai'i County Code, Contingency Relief funds shall be transferred to an accepting County department/agency via resolution identifying the nonprofit organization and the specific program, project, event, activity, service, equipment, materials, or supplies for which the grant shall be used; now, therefore,

**BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI'I** that Contingency Relief funds from Council District 3 will be appropriated to the Department of Liquor Control to provide a grant to Hawai'i Public Health Insitute to assist with expenses for its community outreach efforts.

**BE IT FURTHER RESOLVED** that the Council of the County of Hawai'i hereby transfers/appropriates the following amount as set forth below:
