A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE A GRANT TO THE DANIEL R. SAYRE MEMORIAL FOUNDATION TO PURCHASE WATER HOSE ATTACHMENTS FOR THE HAWAI‘I FIRE DEPARTMENT.

WHEREAS, the Daniel R. Sayre Memorial Foundation is a 501(c)(3) nonprofit organization committed to providing essential equipment to the Hawai‘i Fire Department to help save lives; and

WHEREAS, the Daniel R. Sayre Memorial Foundation has raised over ten million dollars in donations to enhance the Hawai‘i Fire Department, which is vital to its rescue and fire-fighting operations; and

WHEREAS, the Daniel R. Sayre Memorial Foundation is requesting funds-to purchase water hose attachments for the Hawai‘i Fire Department’s fire vehicles; and

WHEREAS, the County of Hawai‘i recognizes the efforts of the Daniel R. Sayre Memorial Foundation to raise funds for the Hawai‘i Fire Department, and is grateful for the generous donations that have made a tremendous impact on the safety and quality of life for Hawai‘i Island residents and visitors; and

WHEREAS, the Hawai‘i Fire Department mission is to provide exceptional, all hazards emergency services to the residents and visitors of Hawai‘i Island; and

WHEREAS, pursuant to Section 2-139(a)(2)(A) of the Hawai‘i County Code, Contingency Relief funds shall be transferred to an accepting County department/agency via resolution identifying the nonprofit organization and the specific program, project, event, activity, service, equipment, materials, or supplies for which the grant shall be used; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I that Contingency Relief funds from Council District 3 will be appropriated to the Hawai‘i Fire Department to provide a grant to the Daniel R. Sayre Memorial Foundation to purchase water hose attachments for the Hawai‘i Fire Department.

BE IT FURTHER RESOLVED that the Council of the County of Hawai‘i hereby transfers/appropriates the following amount as set forth below:
