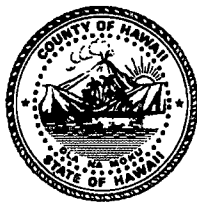

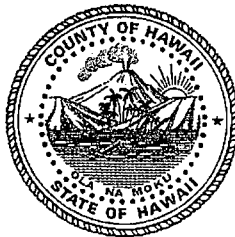
I am requesting approximately thirty (30) minutes for a discussion and status update with Corporation Counsel on long pending cases which involve claims by County employees.


