ORDINANCE NO. 19 41

AN ORDINANCE AMENDING CHAPTER 24, ARTICLE 10, DIVISION 1 OF THE HAWAI'I COUNTY CODE 1983 (2016 EDITION, AS AMENDED), RELATING TO SPEED LIMITS.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAI'I:

SECTION 1. Chapter 24, article 10, division 1 (Speed Limits), section 24-257, schedule 5, 35 mile per hour limit, subsection (c), South Hilo, of the Hawai'i County Code 1983 (2016 Edition, as amended), is amended by revising an existing item to read as follows:


“Kūkūau Street, from a point one hundred fifty feet southwest of Kahikini Street [~~Komohana Street~~] to its [~~mauka~~] southwestern terminus.”

SECTION 2. Material to be repealed is bracketed and stricken. New material is underscored. In printing this ordinance, the brackets, bracketed and stricken material, and underscoring need not be included.

SECTION 3. Severability. If any provision of this ordinance, or the application thereof to any person or circumstance, is held invalid, the invalidity does not affect other provisions or applications of the ordinance, which can be given effect without the invalid provision or application, and to this end, the provisions of this ordinance are severable.

SECTION 4. This ordinance shall take effect upon its approval.
