A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT FOR THE HAWAI‘I ISLE POLICE ACTIVITIES LEAGUE LONG-DISTANCE CANOE REGATTA.

WHEREAS, the Hawai‘i Isle Police Activities League (“HI-PAL”) is a community youth program under the Police Department; and

WHEREAS, HI-PAL activities are provided and designed to help youth make healthy and legal choices; and

WHEREAS, HI-PAL is organizing an inaugural long-distance canoe regatta in Hilo Bay in spring 2017; and

WHEREAS, the Police Department is requesting funds to assist with expenses relating to the long-distance canoe regatta, including, but not limited to, food, refreshments, and the contracting of escort boats for the safety of the participants; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I that Contingency Relief funds from Council District 3 will be appropriated to the Police Department to assist with expenses related to the HI-PAL long-distance canoe regatta in spring 2017.


BE IT FURTHER RESOLVED that the Council of the County of Hawai‘i hereby transfers/appropriates the following amount as set forth below:
