

RESOLUTION NO. 51 17

A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE A GRANT TO HAWAI‘I ISLAND UNITED WAY FOR THE PURCHASE OF MATERIALS AND SUPPLIES FOR ITS COMMUNITY OUTREACH INITIATIVE.

WHEREAS, the Hawai‘i Island United Way (“HIUW”) is a 501(c)(3) nonprofit organization whose mission is to unite people, organizations, and resources to build a healthier community; and

WHEREAS, HIUW is committed to advancing the common good of all by focusing on community transformation in the areas of education, income, and health; and

WHEREAS, every year, HIUW through its 39 partner community organizations helps tens of thousands of people on Hawai‘i Island; and

WHEREAS, HIUW is requesting funds to assist with the purchase of materials and supplies for its community outreach initiative; and

WHEREAS, the Department of Liquor Control supports organizations and programs that promote the health, safety, and welfare of the community; and

WHEREAS, pursuant to Section 2-139(a)(2)(A) of the Hawai‘i County Code, Contingency Relief funds shall be transferred to an accepting County department/agency via resolution identifying the nonprofit organization and the specific program, project, event, activity, service, equipment, materials, or supplies for which the grant shall be used; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I that Contingency Relief funds from Council District 3 will be appropriated to the Department of Liquor Control to provide a grant to Hawai‘i Island United Way to assist with expenses for materials and supplies for its community outreach initiative.

BE IT FURTHER RESOLVED that the Council of the County of Hawaii hereby transfers/appropriates the following amount as set forth below:




