A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT FOR THE HAWAI‘I ISLE POLICE ACTIVITIES LEAGUE FOOTBALL COMBINE/CLINIC AND 7-ON-7 BATTLE BY THE BAY FOOTBALL TOURNAMENT FOR YOUTH.

WHEREAS, the Hawai‘i Isle Police Activities League (“HI-PAL”) is a community youth program under the Police Department that provides activities designed to help youth make healthy and legal choices; and

WHEREAS, HI-PAL is organizing an inaugural, three-day football event in Hilo, to be held June 2017, that will include a combine/clinic and a youth football tournament called 7-on-7 Battle by the Bay; and

WHEREAS, the combine/clinic will test the student athletes’ abilities using various speed, agility, and strength drills; and

WHEREAS, following the combine/clinic, there will be ten teams participating in the 7-on-7 Battle by the Bay football tournament; and

WHEREAS, HI-PAL requests funding assistance for costs related to its three-day football event, including officiating fees for the tournament and T-shirts for the tournament participants; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I that Contingency Relief funds from Council District 3 will be appropriated to the Police Department for its Hawai‘i Isle Police Activities League football combine/clinic and 7-on-7 Battle by the Bay football tournament for youth.

BE IT FURTHER RESOLVED that the Council of the County of Hawai‘i hereby transfers/appropriates the following amount as set forth below:
