A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PURCHASE AND INSTALL A LIGHTING SYSTEM FOR THE PARKING LOT AT THE STANLEY COSTALES WAIĀKEA-UKA GYM.

WHEREAS, the Stanley Costales Waiākea-Uka Gym is located at the Waiākea-Uka Park; and

WHEREAS, residents use and enjoy the Stanley Costales Waiākea-Uka Gym for a wide variety of nighttime activities, including basketball games, volleyball matches, and community meetings and gatherings; and

WHEREAS, the Department of Parks and Recreation has identified the need for a lighting system to be installed at the Stanley Costales Waiākea-Uka Gym to illuminate the adjacent parking lot and to provide safety for users of the gym; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI'I that Contingency Relief funds from Council District 3 will be appropriated to the Department of Parks and Recreation to purchase and install a lighting system for the parking lot at the Stanley Costales Waiākea-Uka Gym.


BE IT FURTHER RESOLVED that the Council of the County of Hawai'i hereby transfers/appropriates the following amount as set forth below:


