A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE A GRANT TO THE BIG ISLAND RESOURCE CONSERVATION AND DEVELOPMENT COUNCIL TO ASSIST WITH EXPENSES RELATED TO THE 2017 HAWAI‘I ISLAND VETERANS DAY PARADE.

WHEREAS, the Big Island Resource Conservation and Development Council (BIRCDC) is a 501(c)(3) nonprofit organization that supports the economic, cultural, and natural environment of Hawai‘i Island through sponsorship of festivals, programs, and special events unique to this island; and

WHEREAS, BIRCDC is working in partnership with the Hawai‘i Island Veterans Day Parade Committee to honor all veterans in Hawai‘i County by coordinating the 2017 Hawai‘i Island Veterans Day Parade in Hilo on November 4, 2017; and

WHEREAS, a financial need has been identified by the organizers of the 2017 Hawai‘i Island Veterans Day Parade to cover necessary expenses, including, but not limited to, special duty police officers, insurance, portable toilets, tents, public address system, and permits; and

WHEREAS, the Office of the Prosecuting Attorney encourages and promotes crime prevention and community initiatives, which improve the quality of life for Hawai‘i Island residents; and

WHEREAS, pursuant to Section 2-139(a)(2)(A) of the Hawai‘i County Code, Contingency Relief funds shall be transferred to an accepting County department/agency via resolution identifying the nonprofit organization and the specific program, project, event, activity, service, equipment, materials, or supplies for which the grant shall be used; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I that Contingency Relief funds from Council District 3 will be appropriated to the Office of the Prosecuting Attorney to provide a grant to the Big Island Resource Conservation and Development Council to assist with expenses related to the 2017 Hawai‘i Island Veterans Day parade.


