

RESOLUTION NO. 305 17

A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO REIMBURSE THE DEPARTMENT OF PARKS AND RECREATION FOR EXPENSES RELATED TO ITS PILIKULĀIWI FALL INTERSESSION PROGRAM.

WHEREAS, the Department of Parks and Recreation, through its Recreation Division, offers a variety of activities for school-age children during the fall intersession; and

WHEREAS, the Recreation Division has established a fall intersession program called Pilikulāiwi, which is a three-day, two-night program for up to 30 youths that will be held in October 2017 in Ka'ū; and

WHEREAS, the Pilikulāiwi program will include a visit to the Keauhou Bird Conservation Center and other sites, as well as a service project to teach about Hawai'i Island and its ecosystem and the importance of mālama honua (to care for our Earth) through hands-on work; and

WHEREAS, the Department of Parks and Recreation requests a reimbursement for lodging costs at Kīlauea Military Camp and T-shirts for the Pilikulāiwi program partners; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI'I that Contingency Relief funds from Council District 3 will be appropriated to the Department of Parks and Recreation as a reimbursement for expenses related to its Pilikulāiwi fall intersession program.


BE IT FURTHER RESOLVED that the Council of the County of Hawai'i hereby transfers/appropriates the following amount as set forth below:
