A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT FOR A STATIONARY BELT/DISC SANDER AND A STATIONARY DRILL PRESS FOR THE DEPARTMENT OF PARKS AND RECREATION.

WHEREAS, the Department of Parks and Recreation is requesting funds to purchase a stationary belt/disc sander and a stationary drill press for its South Hilo Baseyard, to be used island wide to provide the public with safe facilities and grounds; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI'I that Contingency Relief funds from Council District 3 will be appropriated to the Department of Parks and Recreation to purchase a stationary belt/disc sander and a stationary drill press for the Parks Maintenance Division.


BE IT FURTHER RESOLVED that the Council of the County of Hawai'i hereby transfers/appropriates the following amount as set forth below:


