

RESOLUTION NO. 508 18

A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PURCHASE FITNESS EQUIPMENT FOR THE PRINCESS ABIGAIL WAHĪKA‘AHU‘ULA KAWANANAKOA CENTER.

WHEREAS, the Princess Abigail Wahīka‘ahu‘ula Kawanānakoā Center (“Kawanānakoā Center”) is a Department of Parks and Recreation facility that serves as a social, recreational, athletic, and community hub in Keaukaha; and

WHEREAS, the Department of Parks and Recreation would like to purchase fitness equipment for use by the public at Kawanānakoā Center to promote physical fitness and good health; and

WHEREAS, the Department of Parks and Recreation is requesting funds to purchase weights, weightlifting bars, medicine balls, and related accessories; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I that Contingency Relief funds from Council District 3 will be appropriated to the Department of Parks and Recreation to assist with the cost of purchasing fitness equipment for the Kawanānakoā Center.


BE IT FURTHER RESOLVED that the Council of the County of Hawai‘i hereby transfers/appropriates the following amount as set forth below:
