A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE A GRANT TO CAMP AGAPE HAWAI'I TO ASSIST WITH EXPENSES RELATED TO THE 2018 CAMP AGAPE BIG ISLAND.

WHEREAS, Camp Agape Hawai'i is a 501(c)(3) nonprofit organization that provides charitable services to children of the incarcerated, including camps that provide religious, educational, and recreational programs; and

WHEREAS, Camp Agape Hawai'i is organizing the 2018 Camp Agape – Big Island, a four-day camp offered to the children of incarcerated adults for the purpose of providing a safe and nurturing environment, designed to empower and to create positive paths in life to grow into healthy and happy members of the community; and

WHEREAS, the Office of the Prosecuting Attorney and numerous organizations, businesses, and individuals support the efforts of Camp Agape – Big Island to encourage resiliency in children to overcome the emotional distress of having an incarcerated parent, and hardships caused by circumstances that led to incarceration; and

WHEREAS, Camp Agape Hawai'i is requesting funds to assist with the cost of meals, transportation, activities, T-shirts, and other expenses associated with the 2018 Camp Agape – Big Island, scheduled for May 25 through May 28, 2018; and

WHEREAS, the Office of the Prosecuting Attorney supports early intervention initiatives for at-risk youths to improve the quality of life on Hawai'i Island; and

WHEREAS, pursuant to Section 2-139(a)(2)(A) of the Hawai'i County Code, Contingency Relief funds shall be transferred to an accepting County department/agency via resolution identifying the nonprofit organization and the specific program, project, event, activity, service, equipment, materials, or supplies for which the grant shall be used; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI'I that Contingency Relief funds from Council District 3 will be appropriated to the Office of the Prosecuting Attorney to provide a grant to Camp Agape Hawai'i to assist with expenses associated with the 2018 Camp Agape – Big Island.

BE IT FURTHER RESOLVED that the Council of the County of Hawai'i hereby transfers/appropriates the following amount as set forth below:


