A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PURCHASE A BATTING CAGE AND NET FOR ‘ĀINAOLA PARK.

WHEREAS, ‘Āinaola Park is a Department of Parks and Recreation facility located in Hilo that serves as a social, recreational, athletic resource for the residents of Waiākea and its surrounding communities; and

WHEREAS, the Department of Parks and Recreation would like to purchase a batting cage and net to provide a safe facility for baseball and softball players to practice and train at ‘Āinaola Park; and

WHEREAS, the Department of Parks and Recreation will install the batting cage and net as part of a Friends of the Park improvement project with the help of volunteers who will clean up the deteriorated area, and also remove old flooring, weeds, and dirt before installing the batting cage; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I that Contingency Relief funds from Council District 3 will be appropriated to the Department of Parks and Recreation to purchase a batting cage and net for ‘Āinaola Park.


BE IT FURTHER RESOLVED that the Council of the County of Hawai‘i hereby transfers/appropriates the following amount as set forth below:


