**A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE A GRANT TO THE HAWAI'I ISLAND CULTURAL AWARENESS PROJECT FOR A REIMBURSEMENT OF PUBLIC SAFETY AND SANITATION EXPENSES FROM THE 25TH ANNUAL KWXX HO'OLAULE'A.**

**WHEREAS**, the Hawai'i Island Cultural Awareness Project is a 501(c)(3) nonprofit organization that provides charitable activities and educational events in support of cultural media on Hawai'i Island; and

**WHEREAS**, the Hawai'i Island Cultural Awareness Project worked with KWXX FM to build education and awareness of the culture and history of Hawai'i Island through the 25th annual KWXX Ho'olaule'a, a drug-free, alcohol-free, family-friendly, live-music block party that was free and open to the public; and

**WHEREAS**, the 25th annual KWXX Ho'olaule'a was held in Hilo on September 29, 2018, and drew thousands of revelers from around Hawai'i Island; and

**WHEREAS**, the Hawai'i Island Cultural Awareness Project is requesting a reimbursement of expenses to defray the cost of providing police protection, security, medical assistance, traffic safety signage and equipment, sanitation, and post-event cleanup; and

**WHEREAS**, the Department of Liquor Control supports public programs that promote drug-free and alcohol-free community events; and

**WHEREAS**, pursuant to Section 2-139(a)(2)(A) of the Hawai'i County Code, Contingency Relief funds shall be transferred to an accepting County department/agency via resolution identifying the nonprofit organization and the specific program, project, event, activity, service, equipment, materials, or supplies for which the grant shall be used; now, therefore,

**BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI'I** that Contingency Relief funds from Council District 3 will be appropriated to the Department of Liquor Control for a reimbursement of public safety and sanitation expenses from the 25<sup>th</sup> annual KWXX Ho'olaule'a.

**BE IT FURTHER RESOLVED** that the Council of the County of Hawai'i hereby transfers/appropriates the following amount as set forth below:
