A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT FOR SIGNAGE FOR THE KEAUKAHA-PANA‘EWA FARMERS ASSOCIATION NEIGHBORHOOD WATCH.

WHEREAS, Neighborhood Watch is a program of the Police Department that helps to organize concerned citizens to reduce criminal activities in residential areas; and

WHEREAS, the Keaukaha-Pana‘ewa Farmers Association Neighborhood Watch (KPFA Neighborhood Watch) is a community-led organization that works in partnership with the Police Department to reduce crime in the Pana‘ewa Farm Lots area; and

WHEREAS, the Police Department is requesting funding assistance to purchase and install Neighborhood Watch signs for the KPFA Neighborhood Watch; and

WHEREAS, the Police Department supports actively involving the community in crime prevention programs; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I that Contingency Relief funds from Council District 3 will be appropriated to the Police Department to provide Neighborhood Watch signage for the Keaukaha-Pana‘ewa Farmers Association Neighborhood Watch.


BE IT FURTHER RESOLVED that the Council of the County of Hawai‘i hereby transfers/appropriates the following amount as set forth below:
