

RESOLUTION NO. 642 20

A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE A GRANT TO THE KEAUKAHA PANA'EWA COMMUNITY ALLIANCE TO ASSIST WITH EXPENSES RELATING TO THE KEAUKAHA-PANA'EWA FARMERS MARKET.

WHEREAS, the Keaukaha Pana'ewa Community Alliance (KPCA) is a 501(c)(3) nonprofit organization that supports the Keaukaha-Pana'ewa Farmers Market, which is an essential business as defined by the Governor's and Mayor's proclamations related to the COVID-19 emergency; and

WHEREAS, pursuant to the aforementioned State and County emergency proclamations, persons engaging in essential businesses are required to exercise appropriate safety measures to stop the spread of COVID-19; and

WHEREAS, KPCA is requesting funding assistance for the continuation of safe operations at the farmers market, including bags, face masks, hand sanitizer, a hand washing station, and printing expenses to provide for public education; and

WHEREAS, the Department of Liquor Control supports organizations that provide drug-free and alcohol-free events for the community; and

WHEREAS, pursuant to Section 2-139(a)(2)(A) of the Hawai'i County Code, Contingency Relief funds shall be transferred to an accepting County department/agency via resolution identifying the nonprofit organization and the specific program, project, event, activity, service, equipment, materials, or supplies for which the grant shall be used; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI'I that Contingency Relief funds from Council District 3 will be appropriated to the Department of Liquor Control to provide a grant to the Keaukaha Pana'ewa Community Alliance for funding assistance related to the operation of essential business activities at Keaukaha-Pana'ewa Farmers Market.

BE IT FURTHER RESOLVED that the Council of the County of Hawai'i hereby transfers/appropriates the following amount as set forth below:
