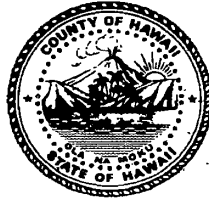

available Council agenda.

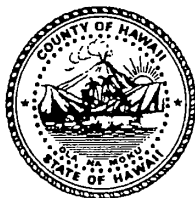


