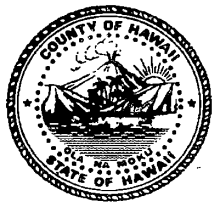

available Council agenda.

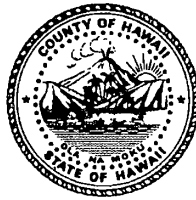
