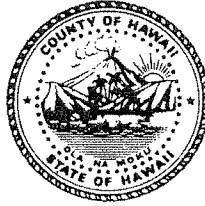




Due to the time-sensitive nature of this resolution, I am requesting a waiver from the appropriate Committee for placement on the next available Council agenda.

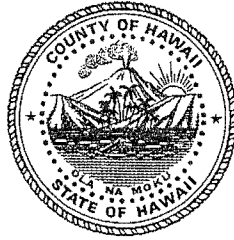
