A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE A GRANT TO THE WAIĀKEA HIGH SCHOOL PARENT TEACHER STUDENT ASSOCIATION FOR THE 2022 WAIĀKEA HIGH SCHOOL PROJECT GRAD NIGHT.

WHEREAS, the Waiākea High School Parent Teacher Student Association (PTSA) is a subordinated unit of PTA Hawai‘i Congress, a 501(c)(3) nonprofit organization; and

WHEREAS, the Waiākea High School PTSA assists Waiākea High School and its students with programs and activities, including the Waiākea High School Project Grad Night for graduating seniors; and

WHEREAS, Project Grad Night activities are designed to provide a healthy and safe venue for graduates; and

WHEREAS, the Waiākea High School PTSA is requesting funds to defray the cost of rental fees, supplies, and equipment for the 2022 Project Grad Night for graduating seniors; and

WHEREAS, one of the Department of Liquor Control’s goals is to support programs that promote the health, education, and well-being of the youth in our community with alcohol- and drug-free events such as graduation ceremonies; and

WHEREAS, pursuant to Section 2-139(a)(2)(A) of the Hawai‘i County Code, Contingency Relief funds shall be transferred to an accepting County department/agency via resolution identifying the nonprofit organization and the specific program, project, event, activity, service, equipment, materials, or supplies for which the grant shall be used; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I that Contingency Relief funds from Council District 3 will be appropriated to the Department of Liquor Control to provide a grant to the Waiākea High School Parent Teacher Student Association for the 2022 Waiākea High School Project Grad Night for graduating seniors.

BE IT FURTHER RESOLVED that the Council of the County of Hawai‘i hereby transfers/appropriates the following amount as set forth below:
