

RESOLUTION NO. 398 22

A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE A GRANT TO THE HILO HIGH SCHOOL FOUNDATION FOR THE 2022 HILO HIGH GRAD NITE.

WHEREAS, the Hilo High School Foundation is a 501(c)(3) nonprofit organization that assists Hilo High School and its students with programs and activities, including the Hilo High Grad Nite; and

WHEREAS, the Hilo High Grad Nite provides a safe, secure, and supervised celebration alternative to the traditional graduation parties that involve underage drinking, illegal substance use, and unsupervised late-night partying that normally results in drinking and driving, all of which pose a hazard to the community; and

WHEREAS, this alcohol- and drug-free event provides the parents and families of the graduates with the peace of mind that their child is in a safe and wholesome environment after graduation; and

WHEREAS, the Hilo High School Foundation is requesting funds to defray the cost of rental fees, supplies, and equipment; and

WHEREAS, one of the Department of Liquor Control's goals is to support programs that promote the health, education, and well-being of the youth in our community with alcohol- and drug-free events such as graduation ceremonies; and

WHEREAS, pursuant to Section 2-139(a)(2)(A) of the Hawai'i County Code, Contingency Relief funds shall be transferred to an accepting County department/agency via resolution identifying the nonprofit organization and the specific program, project, event, activity, service, equipment, materials, or supplies for which the grant shall be used; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I that Contingency Relief funds from Council District 3 will be appropriated to the Department of Liquor Control to provide a grant to the Hilo High School Foundation for the 2022 Hilo High Grad Nite.

BE IT FURTHER RESOLVED that the Council of the County of Hawai'i hereby transfers/appropriates the following amount as set forth below:
