INSTRUCTIONS

1. If there are more than one application for the same special plate, the application first processed shall have priority.
2. The \$60 special number plate fee shall be charged upon initial application and each subsequent renewal of the vehicle which has been assigned the special plate. This \$60 fee shall be **IN ADDITION TO ALL REGULAR FEES AND TAXES** on motor vehicles and is not refundable.
3. You will be notified by letter as soon as your special plates are ready for assignment. Please submit the currently issued Certificate of Registration, license plates currently on the vehicle and the notification letter. **YOU WILL BE CHARGED AN EMBLEM REPLACEMENT FEE.** If your registration has expired or will expire within 45 days of processing the special plate replacement, applicable renewal fees and taxes will be charged.
4. If loss, defacement or destruction of a special plate occurs, you may request for replacement plates of the **SAME** special number with a payment of \$20.00. Regularly issued license plates will be assigned until your replacement special plates are ready for assignment. **YOU WILL BE CHARGED A PLATE AND EMBLEM REPLACEMENT FEE** in addition to all taxes and fees which may be applicable under Chapter 249, Hawaii Revised Statutes, for renewal.
5. Special plates may be transferred to another vehicle. Please submit current Certificate of Registration for **BOTH** vehicles. **YOU WILL BE CHARGED PLATE TRANSFER FEES AND EMBLEM REPLACEMENT FEES** in addition to all fees and taxes which may be applicable under Chapter 249, Hawaii Revised Statutes, for renewal and/or transfer of ownership.
6. If you desire to keep your special plates upon transfer of ownership of a vehicle to which it has been assigned and do not have another vehicle for assignment of your special plates, you must **SURRENDER** your special plates and obtain regularly issued plates **BEFORE** selling your vehicle. Please submit the currently issued Certificate of Registration and your special plates. **YOU WILL BE CHARGED A PLATE AND EMBLEM REPLACEMENT FEE** in addition to all fees and taxes which may be applicable under Chapter 249, Hawaii Revised Statutes, for renewal.
