A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE A GRANT TO VIBRANT HAWAI'I TO ASSIST WITH EXPENSES RELATING TO THE 27th ANNUAL KWXX HO'OLAULE'A.

WHEREAS, Vibrant Hawai'i is a 501(c)(3) nonprofit organization that brings community-based organizations, government, foundations, and businesses together to build awareness and implement strategies that are developed and resourced by the community; and

WHEREAS, KWXX FM is a radio station that is hosting its 27th Annual KWXX Ho'olaule'a on January 28, 2023, in downtown Hilo; and

WHEREAS, Vibrant Hawai'i is working with KWXX FM to increase awareness of the culture and history of Hawai'i Island by presenting the annual KWXX Ho'olaule'a, a free block party featuring live contemporary and traditional music and hula in downtown Hilo; and

WHEREAS, the annual KWXX Ho'olaule'a is a drug-free and alcohol-free family-friendly event with numerous stages and entertainers positioned around downtown Hilo that attracts residents from around the island; and

WHEREAS, Vibrant Hawai'i is requesting funds for security, clean-up expenses, and traffic safety signage; and

WHEREAS, the Department of Liquor Control supports organizations that provide compliance to liquor laws at drug-free and alcohol-free events; and

WHEREAS, pursuant to Section 2-139(a)(2)(A) of the Hawai'i County Code, Contingency Relief funds shall be transferred to an accepting County department/agency via resolution identifying the nonprofit organization and the specific program, project, event, activity, service, equipment, materials, or supplies for which the grant shall be used; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI'I that Contingency Relief funds from Council District 3 will be appropriated to the Department of Liquor Control to provide a grant to Vibrant Hawai'i to assist with expenses for the 27th Annual KWXX Ho'olaule'a.

BE IT FURTHER RESOLVED that the Council of the County of Hawai'i hereby transfers/appropriates the following amount as set forth below:
