**A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM A DESIGNATED FUND ACCOUNT AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT TO PROVIDE A GRANT TO THE ISLAND OF HAWAI‘I YMCA TO ASSIST WITH EXPENSES RELATED TO THE PURCHASE AND INSTALLATION OF A WATER BOTTLE FILLING STATION.**

**WHEREAS**, the Island of Hawai‘i YMCA (YMCA) is a 501(c)(3) nonprofit organization that supports the community through its programs and activities in youth development, healthy living, and social responsibility; and

**WHEREAS**, the YMCA provides health and fitness classes, day camps, online education, family visitations, etc., and is seeking assistance to purchase and install a water bottle filling station to provide a healthy environment for its participating members; and

**WHEREAS**, the Department of Liquor Control supports organizations that bring awareness and education to our youth and community on living a healthy, alcohol-free, and drug-free lifestyle; and

**WHEREAS**, pursuant to Section 2-139(a)(2)(A) of the Hawai‘i County Code, Contingency Relief funds shall be transferred to an accepting County department/agency via resolution identifying the nonprofit organization and the specific program, project, event, activity, service, equipment, materials, or supplies for which the grant shall be used; now, therefore,

**BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I** that Contingency Relief funds from Council District 3 will be appropriated to the Department of Liquor Control to provide a grant to the Island of Hawai‘i YMCA to assist with expenses related to the purchase and installation of a water bottle filling station.

**BE IT FURTHER RESOLVED** that the Council of the County of Hawai‘i hereby transfers/appropriates the following amount as set forth below:


