I also handled hearings before the Planning Commission and Hearing Officers. I was also assigned to investigate and litigate employment related issues.

Prior to becoming an Attorney in 1976 I worked for the State of California Department of Employment, both as a Staff Trainer in both Employment and Unemployment Insurance matters and as an adjudicator making investigations into reasons for leaving employment as well as Super4vising a State Employment Office.
