This past, last week Thursday, March 31st, there was a public hearing held in Hilo at our 50 Wailuku conference room and by teleconference, by televideo to our Kona Office at the West Hawai'i Civic Center. There were no individuals that came forth to provide public testimony and so we submit, we will be submitting the plan once you approve it to HUD as written.

Mr. Ilagan: Thank you. Moving on to our discussion, any agency members wish to, okay. Moving on to our vote, we're gonna do a voice vote, all in favor please say aye.
