EnvironMETeo Services, Inc. (EMET) is environmental consulting firm established in 1986. EMET would like to be considered to provide professional services for projects during the fiscal year 2025-2026 in the following categories:

EMET provides environmental services that include but are not limited to: environmental property (site) assessments, industrial hygiene services, asbestos survey, lead paint survey, hazardous materials identification and project management. Hazardous material mitigation plans, specifications, permit application preparation, source emission testing, and indoor/outdoor ambient air quality monitoring.

EMET's professional staff of twenty includes a Certified Industrial Hygienist (CIH), a registered Architect, State of Hawaii certified building inspectors, project



monitors, management planners, project designers, EPA certified lead risk assessors, supervisors and project designers, industrial hygienists (IH), and laboratory analysts in both identification and fiber counting. EMET has maintained an average size staff of 14 individuals over the past 5 years.

Our staff is experienced and trained in the use of a wide variety of environmental monitoring instrumentation including stationary source testing equipment, ambient air monitors, noise and indoor air quality instrumentation. Eight members of our source emission test team are certified by the State of Hawaii as visible emissions observers, which qualify our firm to certify smoke opacity, and fugitive dust readings for regulatory compliance.

EMET's comprehensive program of air quality monitoring and emissions testing include, but are not limited to, particulate matter, total suspended particulate, sulfur oxides, carbon dioxide, carbon monoxide, nitrogen oxides, hydrogen chloride, hydrogen sulfide, hydrocarbon, VOC's, BTEX, PNA's, cadmium, lead, mercury, heavy metals, asbestos, formaldehyde and bioaerosols. Ambient indoor and outdoor air pollution, industrial hygiene services, environmental site assessments (phase 1 and 2), environmental impact studies, state and PSD air permitting and air quality modeling.

EMET's analytical laboratory is a successful participant in the National Institute for Occupational Safety and Health (NIOSH) Proficiency Analytical Testing (PAT) program for airborne fiber analysis. EMET is also accredited by the National Institute of Standards and Technology (NIST), National Voluntary Laboratory Accreditation Program (NVLAP) for asbestos fiber analysis and identification, created under the (AHERA) Asbestos Hazard Emergency Response Act.

EMET has completed over 7000 facility site surveys for asbestos containing materials and lead paint and have developed and implemented over 300 Operation and Maintenance (O&M) programs relating to asbestos containing materials and lead paint exposure hazard. Our specialized experience includes 1995, 1998, 2013, 2016 and 2019 Department of Education AHERA inspection of its school facilities (in excess of 3000 buildings) and the 1998 Department of Education Lead Paint Investigation of all its elementary schools (1500 buildings).



EMET has an established track record demonstrating it is capable of performing high quality work, within specified time frames, in compliance with all performance schedules and budgets. Past and current contracts have had strict time restraints, which we have always met. Our staff is well familiar with State of Hawaii and U.S. Environmental Protection Agency testing procedures, protocols and regulatory requirements.
