ORDINANCE NO. 00 121

AN ORDINANCE AMENDING CHAPTER 14, ARTICLE 10 OF THE HAWAII CODE, AS AMENDED RELATING TO EXCEPTIONAL TREES

BE IT ORDAINED BY THE COUNCIL OF HAWAII

SECTION 1 Chapter 14, Article 10, of the Hawaii County Code, 1993, is amended by adding [two] a tree to the existing list of twenty nine trees, as follows

SECTION 14-65 Designated Exceptional Trees

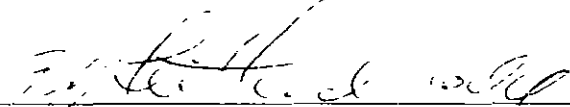
