ORDINANCE NO. 03 145

AN ORDINANCE AMENDING CHAPTER 14, ARTICLE 10, OF THE HAWAI'I COUNTY CODE, AS AMENDED, RELATING TO EXCEPTIONAL TREES.

BE IT ORDAINED BY THE COUNCIL OF HAWAI'I:

SECTION 1. Chapter 14, Article 10, of the Hawai'i County Code, 1993 is amended by adding a tree to the existing list of thirty-two exceptional trees, as follows:

Section 14-65. Designated Exceptional Trees.

The following tree is designated as an "Exceptional Tree" of the County of Hawai'i:

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this ordinance, the brackets, bracketed material and underscoring need not be included.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.
