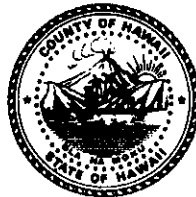

ORDINANCE NO. 06 1.35

AN ORDINANCE AMENDING CHAPTER 14, ARTICLE 10, OF THE HAWAI'I COUNTY CODE 1983 (2005 edition), RELATING TO EXCEPTIONAL TREES.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAI'I:

SECTION 1. Chapter 14, Article 10, Section 14-65, Hawai'i County Code 1983 (2005 Edition) is amended by adding a tree to the existing list of exceptional trees, as follows, and numbered accordingly:

Section 14-65. Designated exceptional trees.

The following tree is designated as an "Exceptional Trees" of the County of Hawai'i:

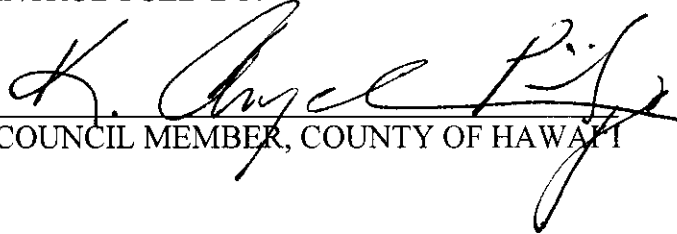
