Aloha Mr. Yee,

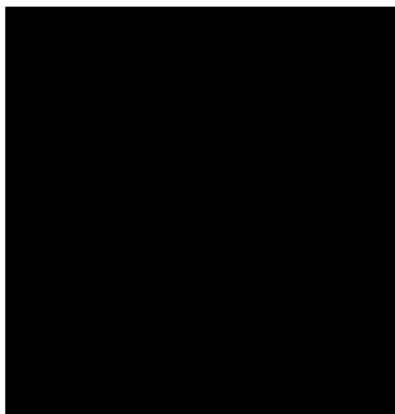

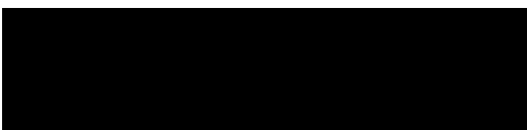
