ORDER DISMISSING PETITION

By Petition dated March 15, 2024, with the Hawaii County Board of Ethics (hereinafter "the Board"), Petitioner JOLEEN L. K. NAKANO (hereinafter "Petitioner") alleged violations of Hawaii County Code Section 2-83(a)(3) of Fair Treatment by Respondent [REDACTED] (hereinafter "Respondent").

At its duly noticed meeting of May 8, 2024, the Board reviewed and considered the above-captioned Petition in a closed hearing pursuant to Rule 4 of the *Rules of Practice and Procedure of the Board of Ethics*. Petitioner appeared in person provided her testimony before the Board. The Board received and reviewed evidence submitted by the Petitioner. Respondent appeared provided [REDACTED] testimony before the Board. Respondent provided the testimony of a witness. The Board asked questions of the parties and witness and clarified the ethical question before the Board. During the questions, the Board were made aware of additional witnesses and continued to hear from the Petitioner's witnesses.

At its duly noticed meeting of June 12, 2024, the Board continued its review and consideration of the above-captioned Petition in a closed hearing pursuant to Rule 4 of the *Rules of Practice and Procedure of the Board of Ethics*. Petitioner appeared in person and submitted

oral testimony of three witnesses to the Board via Zoom conference technology. Respondent appeared in person with the assistance of counsel. The Board asked questions of the witnesses and allowed the Respondent to respond to the submitted testimony. The Board continued to hear from the Respondent's witnesses.

At its duly noticed meeting of July 17, 2024, the Board continued its review and consideration of the above-captioned Petition in a closed hearing pursuant to Rule 4 of the *Rules of Practice and Procedure of the Board of Ethics*. Petitioner appeared in via Zoom conference technology. Respondent appeared in person with the assistance of counsel. Respondent via counsel had filed a Motion to Dismiss. The Board reviewed and considered the motion. Board Member Christopher Ho moved to deny Respondent's Motion to Dismiss. The motion was seconded by Board Member Scotty Paiva. The Board unanimously approved the motion to deny the Respondent's Motion to Dismiss by a vote of 4-0. The Board then heard from the three witnesses presented by Respondent via Zoom conference technology and over the phone. The Board asked questions of the witnesses.

The Board having examined and weighed the record and files in this case and the evidence submitted by the Petitioner and Respondents, Board Member Christopher Ho moved to dismiss Petition 2024-02 pursuant to Board of Ethics Rule 4.8 because the evidence fails to meet the burden of showing a probable violation of the Hawai'i County Code of Ethics. The motion was seconded by Board Member Denise Nakanishi. The Board unanimously approved the motion to dismiss Petition 2024-02 by a vote of 4-0.

ORDER

Based upon the foregoing, the Hawai'i County Board of Ethics orders that Petition No. 2024-02 is hereby dismissed. Pursuant to Board Rule 4.9, the Order Dismissing the Petition shall be filed and a copy shall be sent to the Petitioner and Respondent.
