❖ **Pololu Lookout**

- There will be a small informal meeting on the future of Pololu lookout with the neighbors & landowners of this area.
 - ❖ Kohala Preserve (KP Holdings) has applied for a permit to reconsolidate & re-subdivide the old mule station area.

❖ **Akoakoa Point**

- Leigh Leong is the new point person for this project.
 - ❖ Joe will set up a site visit for early next year.

❖ **Keokea (Nuili)**

- Betsy Cole of Kohala Center is aware about the access ~~easement~~ situation.
 - ❖ There will be a meeting with Kohala Center soon to discuss this access issue.

- Na Ala Hele advisory council last meeting was in Waimea on October 10.
 - ❖ Na Ala Hele did submit an appropriation proposal to the land division for trail improvements but got denied.
 - We should send a letter to the land division supporting this project and cc the legislators.
 - We should set up a meeting with landowners and government agencies to discuss the Pua Kea bay trail.
